Producción forestal maderable	Algunos totales no coinciden con la suma de los parciales debido al redondeo. Las especies forestales explotadas se agrupan en las categorías siguientes: Coníferas, Latifoliadas, Maderas tropicales preciosas y Maderas tropicales comunes. El producto más frecuentemente explotado en selvas, bosques y matorrales es la madera, pero hay otro tipo de materiales que también son explotados, por ello, los bienes forestales se dividen en maderables y no maderables. La producción forestal maderable se subdivide según la especie empleada: a) Pino y otras coníferas que incluye cedro blanco (<i>Cupressus spp</i>), ciprés (<i>Taxodium spp</i>) y tascate (<i>Juniperus spp</i>), entre otras especies; b) Encino y otras latifoliadas, estas últimas son especies maderables de zonas templadas y semiáridas entre las que destacan: álamo, liquidámbar, mezquite, fresno, nogal y siricote. c) Preciosas: se trata de caoba (<i>Swietenia macrophylla</i>) y cedro rojo (<i>Cedrella odorata</i> y <i>C. mexicana</i>), especies que por sus propiedades y características estéticas son de alta estimación y tienen un alto valor comercial. d) Comunes: se refiere a las especies maderables de clima tropical distintas a la caoba y al cedro rojo, entre las cuales están: Chechen, jabín, pucté, mangle rojo, ébano, habillo, primavera y ceiba. De acuerdo a los usos principales de la madera en México tenemos la Escuadría: madera rolliza destinada principalmente a la producción de tablas y tablones, vigas y material de empaque. Chapa: lámina delgada de madera de dimensiones variables obtenida por el torneado o rebano de la madera en rollo, que se utiliza para ser pegada con otro material. Postes, pilotes y morillos: maderas rollizas destinadas a soportar redes de cables y bases para cercas. También se utilizan como soporte y travesaños en las estructuras de sostén y armazones de los ductos subterráneos de las minas, así como parte estructural de construcciones.
